ELIGIBILITY

Open to all artists 18 years and older. In an effort to pursue high quality, all artwork must be original work executed by the artist within the last two years

ENTRY FEE

Artists may submit up to three works for a non-refundable processing fee of \$35.00. Members of the Foundry Art Centre may submit up to three works for a non-refundable fee of \$24.00. Make checks payable to Foundry Art Centre.

MEDIA & SPECIFICATIONS

All fiber media in 2D and 3D form will be considered.

PROCEDURE / SLIDES, JPEGS ENTRY & CD ENTRY

A maximum of three entries per artist may be submitted for consideration. Submit for jurying, one 35 mm slide per entry (cardboard or plastic mounts). On the front view, label slides with name, medium, and the slide # that conforms to entry form. Put a red dot in the lower left corner of each slide. Non-accepted slides will be returned only if a S.A.S. E. is enclosed.

In lieu of slides, artists may submit three jpegs (limit image to 1024 pixels on the longest side) via email:

showentry@foundryartcentre.org or on CD (PC format only and no PowerPoint, just raw jpeg files). Include required information (name, medium, and the entry #) with each image sent as it corresponds to entry form. Slides, CDs and jpegs must accurately depict accepted work or the work will not be installed.

Works must be shipped at the artist's expense to: Foundry Art Centre: 520 North Main Center, St. Charles, MO 63301. Accepted artists shipping their work must include prepaid charges for return shipping. Hard-delivered works must be picked up within thirty days of the close of the exhibition at the Foundry Art Centre or work becomes property of F.A.C. to dispose of as it sees fit.

SALES

All work submitted must be available for purchase at the time of the exhibition. The Foundry Art Centre will retain a 35% commission on all sales directly attributed to the exhibition. All prices (including frame), set by the artist at the time of entry to include the 35% commission. The price will remain the sale price for the duration of the exhibition. Sales will be encouraged through patron, corporate, and individual purchases.

SHIPPING & RETURN OF ACCEPTED WORK

Accepted works are to be hand-delivered or shipped in a single reusable crate(s)/carton(s). Include with each work two 3" x 5" cards listing Name, Address, Phone, Title, Media, Dimensions, and Value. Attach one of the cards to the back of 2D work or base of 3D work.

PUBLICITY

The Foundry Art Centre reserves the right to photograph and reproduce, in color or black & white, all artworks accepted for this exhibition, regardless of copyright, for educational and/or publicity purposes.

LIABILITY AND INSURANCE

Foundry Art Centre provides standard insurance at 50% of retail on all exhibited works while on premises. Artist responsible for work in transit to and from.
