**F**IBRATIONS is an exhibition of the work of the members of Missouri Fiber Artists (MoFA) to be held at Waverly House Gallery in Springfield, MO during the month of October, 2010.

Opening in 1987, Waverly House has become the regional destination for fine art and contemporary American craft. Waverly House is the only American Style Preferred Gallery in SW Missouri and a Niche 2009 Top Retailer Nominee as well as an active long-term supporter of art and artists, locally and statewide.

MoFA members are invited to submit artwork that celebrates fiber art in all its various forms.

## SUBMISSIONS

- Artists must be current members of MoFA. To join, go to: [www.missourifiberartists.com](http://www.missourifiberartists.com).
- Maximum of two pieces may be entered per artist.
- Pieces must have been completed in the past 3 years.
- All the pieces must be artist's original design or concept and executed solely by the artist.
- Pieces executed under classroom /educational/ supervisory guidance are not eligible.
- Artwork must fit through a standard door and be able to be handled safely by one person.
- There is no jury fee. There will be a \$15 participation fee for all accepted artists. Money will be used to defray the costs of publicity for the exhibition.

## JURYING

- Exhibition Committee will review all images and make the exhibition selections.

## EXHIBITION & SALES

- All accepted work must be for sale and must remain in the Gallery for the duration of the exhibition.
- Artist will receive 60% of the sales price for sales that result from the exhibition, including commissions.
- Wall space is always at a premium, so please limit the size of wall-hung work to no more than 36" x 36".
- Waverly House has a limited number of mannequins available for display of wearable art.

## INSURANCE & SHIPPING

- All costs of shipping work to and from the Gallery, including transit insurance, are the financial responsibility of the artist.
- Use sturdy, reusable containers for shipping, as work will be returned in the original shipping cartons. Do not

use loose packing peanuts.

- Although work is not insured by Waverly House, all care is taken to protect the work while on the premises. Artists are advised to carry their own insurance.

## IMAGES

- Only digital images in .jpg format on CD will be accepted.
- Images must accurately represent the work.
- Maximum of 2 images per piece, either 2 views or 1 full + 1 detail.
- Images must be 7" in the longest dimension, saved at 180 dpi.
- Label each image as follows:  
Artist name, title of work, entry number, view.jpg. Example:  
Jones\_Dawn\_Breaks\_1\_full.jpg  
Jones\_Dawn\_Breaks\_1\_detail.jpg  
White\_Arriba\_2\_front.jpg  
White\_Arriba\_2\_side.jpg
- Label CD with Artist name and number of images included.
- Please test your CD to make sure it is readable before sending.
- Images will become the property of MoFA.

## SCHEDULE

- Deadline for receipt of entries is Friday, July 23, 2010. (Not a postmark date)
- Notification along with delivery instructions will be e-mailed August 6, 2010.
- Accepted work must be received by September 20, 2010.

## APPLICATION REQUIREMENTS

- CD with images (all labeled as directed above).
- Completed entry form.
- Artist's Statement: One page maximum related to art work submitted.
