MoFA members are invited to submit artwork that celebrates fiber art in all its various forms.

SUBMISSIONS

- Artists must be current members of MoFA. To join, go to: www.missourifiberartists.com.
- Maximum of three pieces may be entered per artist.
- All the pieces must be artist's original design or concept and executed solely by the artist.
- Artwork must fit through a standard door and be able to be handled safely by one person.
- There is a \$5 per piece participation fee.

JURYING

- Exhibition Committee will review all images and make the exhibition selections.

EXHIBITION & SALES

- Artist will receive 60% of the sales price for sales that result from the exhibition.

INSURANCE & SHIPPING

- All costs of shipping work to and from the Gallery, including transit insurance, are the financial responsibility of the artist.
- Use sturdy, reusable containers for shipping, as work will be returned in the original shipping cartons. Do not use loose packing peanuts.
- Although work is not insured by Capital Arts, all care is taken to protect the work while on the premises. Artists are advised to carry their own insurance.

IMAGES

- Only digital images in .jpg format on CD will be accepted.
- Images must accurately represent the work.
- Maximum of 2 images per piece, either 2 views or 1 full + 1 detail.
- Images must be 7" in the longest dimension, saved at 72 dpi.
- Label each image as follows: Artist name, title of work, entry number, view.jpg. Example:
 Jones_Dawn_Breaks_1_full.jpg Jones_Dawn_Breaks_1_detail.jpg
 White_Arriba_2_front.jpg White_Arriba_2_side.jpg
- Label CD with Artist name and number of images included.
- Please test your CD to make sure it is readable before sending.
- Images will become the property of MoFA.

SCHEDULE

- Deadline for receipt of entries is Friday, January 14, 2011. (Not a postmark date)
- Notification along with delivery instructions will be e-mailed February 4, 2011.
- Accepted work must be received by February 23, 2011.

APPLICATION REQUIREMENTS

- CD with images (all labeled as directed above).
- Completed entry form.
- Artist’s Statement: One page maximum related to art work submitted.
